PSS agrees with ELITechGroup for 5-year supply agreement for OEM products

Precision System Science Co., Ltd. (“PSS“ hereafter) has recently agreed with ELITechGroup SAS (France, <https://www.elitechgroup.com/>, “ELITech“ hereafter), to enter into a 5-year supply agreement for certain OEM products. ELITech was recently acquired by the publicly listed US company Bruker Inc. The key terms of the agreement are described below:

PSS has been supplying ELITech with the fully automated sample-to-answer molecular systems “ELITE InGenius“ as well as dedicated nucleic acid extraction reagents/plastic consumables since 2015. For the sake of a more stable manufacturing and supply of the OEM products, both parties have agreed to enter into a long-term supply agreement with a five year term from Jul/2024 to Jun/2029. Based on this agreement, ELITech will place a order amounting to a total of approximately JPY 7 billion over the term of the agreement. To securely fulfill the agreement, PSS intends to optimize the operations of its major manufacturing plants including the Odate Reagent Center as well as external manufacturing partners and to ensure continuous and stable manufacturing at those plants.

“Elitech has been collaborating with PSS for more than 10 years. Thanks to development and the commercialization of InGenius and BeGenius, PSS and ELITech together did create a new market segment that previously did not exist. Based on the continued success of our innovative molecular diagnostic systems we decided to enter into a long-term supply agreement with PSS. Our commitment underlines the importance of the strategic partnership between our companies“
